**(c) Junior Engineer (Information Technology):** PGDCA/B.Sc., (Computer Science)/BCA/ B.Tech. (Information Technology)/B.Tech. (Computer Science)/DOEACC 'B' Level Course of 3 years duration or equivalent from recognised university/institute.

**(d) Chemical and Metallurgical Assistant:** Bachelors Degree in Science with Physics and Chemistry with minimum of 45% marks.

**5.0 Stage of Examination:**

There shall be two stage computer based test (CBT) followed by document verification and medical examination.

**6.0 Medical Standards:** Candidates must ensure that they fulfil the prescribed medical standards for the post(s) they are opting for. Refer to the medical standards for each post as available in the detailed CEN published in the websites of RRBs. Candidates found medically unsuitable for the opted post(s) shall not be given any alternative appointment.
