Whereas, Notification cited at reference (4) adhering to the terms and conditions stipulated in the Government Notification cited at reference (2 & 3) for selection of **50 Posts** of Reserve Police Constable (Mounted Company) to K.A.R.P. Mounted Company, Mysuru was published in the Karnataka State Gazette.

The Recruitment Committee conducted written examination on **18.10.2020** to all the candidates who were found eligible in pursuant to the above notification. After written examination qualified candidates were called for Endurance Test and Physical Standard Test held on **18.12.2020** & **24.12.2020** in the ratio of 1:5.

DIGP, Training & Recruitment, Bangalore prepared the Merit List based on the Percentage of the Marks obtained by the candidate in the written exam conducted by the Selection Authority after taking into consideration the reservation of posts as in Notification cited at reference (4). Provisional Select List for the posts of Reserve Police Constable (Mounted Company) been prepared is as under.
